

**Nevada State Performance Plan

Mineral County School District Performance Indicator Data – 2006-2007**

The Individuals with Disabilities Education Act (IDEA 2004) requires states to develop and submit a six-year State Performance Plan (SPP) to the Office of Special Education Programs (OSEP) at the U.S. Department of Education. The SPP is designed to evaluate the state's efforts to implement the requirements and purposes of IDEA and describe how the state will improve its implementation. The plan consists of several priority areas with specific indicators defined for each area. Measurable and rigorous targets are defined for each indicator to show progress throughout the six-year period. For school year 2006-2007, states are required to report publicly on the performance of school districts for SPP indicators 1, 2, 3, 4a, 5, 8, 9, 10, 11, 12, and 13. The table below shows how this school district performed on specific indicators and whether or not the district met the state's annual targets for those indicators as defined in the Nevada State Performance Plan.
