

**Nevada State Performance Plan
Annual Performance Report
Carson City School District Performance Indicator Data – 2007-2008**

The Individuals with Disabilities Education Act (IDEA 2004) requires states to develop and submit a six-year State Performance Plan (SPP) to the Office of Special Education Programs (OSEP) at the U.S. Department of Education. The SPP is designed to evaluate the state's efforts to implement the requirements and purposes of IDEA and describe how the state will improve its implementation. The plan consists of several priority areas with specific indicators defined for each area. Measurable and rigorous targets are defined for each indicator to show progress throughout the six-year period. For school year 2007-2008, states are required to report publicly on the performance of school districts for SPP indicators 1, 2, 3, 4a, 5, 8, 9, 10, 11, 12, 13, and 14. The table below shows how this school district performed on specific indicators and whether or not the district met the state's annual targets for those indicators as defined in the Nevada State Performance Plan.

Determination Under IDEA for 2007-2008

In accordance with federal requirements under the Individuals with Disabilities Education Act (IDEA), the Nevada Department of Education (NDE) is required to make an annual determination of each school district's status in implementing the purposes and requirements of Part B of the IDEA. This annual determination is based upon a review of each district's data against the state targets established for performance and compliance indicators under the Nevada State Performance Plan. "Performance" indicators for school year 2007-2008 include Indicators 1, 2, 3, 4a, 5, 8, and 14. "Compliance" indicators for school year 2007-2008 include Indicators 9, 10, 11, 12, and 13.

The NDE has completed its review of the data that the school district submitted for school year 2007-2008, and the results of the review were used to make a determination for the school district. School districts that were determined to "meet requirements" reported accurate and timely data and demonstrated substantial compliance or correction of noncompliance at a 95% rate. Districts that were determined to "need assistance" did not report accurate and/or timely data but took action to correct, demonstrated substantial compliance or correction of noncompliance at a 50-94% rate and/or demonstrated progress in correcting noncompliance, and met a target for at least one performance indicator.

Based on these criteria, the Carson City School District determination for 2007-2008 is: **Needs Assistance.**
