## Notice of Workshop to Solicit Comments on Proposed Regulation

The Nevada Department of Education is proposing regulation language pertaining to the Nevada Administrative Code. The Workshop has been scheduled for **August 17, 2017** via video conference at the following locations: **Nevada Department of Education Offices, Board Conference Room, 700 East Fifth Street, Board Room, Carson City and 9890 South Maryland Parkway, 2<sup>nd</sup> Floor Board Conference Room, Las Vegas, Nevada.** The purpose of the Workshop is to solicit comments from interested person on the following general topics to be addressed in a proposed regulation:

**9:25 A.M. Workshop to Solicit Comments on Proposed Amendments to NAC Chapter 391 Regarding the Distribution of Teacher Incentives. Passage of AB434 during the 2017 Legislative Session requires the State Board of Education to establish regulations to carry out the teacher incentives.**
